## About us

We are working on the issues like Health, Education, and Women empowerment, Self Help Groups, Agriculture and Environment. Especially our focus is to provide equal chances of business, education and health to youth of unorganized sector, women, children and economically deprived community. Organisation arrange training program for community to encourage and develop independent business. We are also joined with activities like natural resources management and agriculture. Our main strength lies in our experienced team thus we can implement our program successfully from grassroots level.

This organization was established in 1993 by the collective efforts of a social worker Mr. Nayanbhai Gandhi, Pushpaben Patel, Surshbhai Gohil and Dhirubhai Vagadia. At that time, it was decided to work according to the ideas and vision of the founders for the purpose of the improvement in health and education services of Amreli district. As per it organisation started its work of Primary education and Reproductive and Child Health program. We have been discussed to join livelihood program for women after seven year of establishment and started vocational training for women. Organization also included

activities like construction of houses for Agariya who are living on peripheral areas of sea, renovation of historical places and educational researches. Now as per our huge experience, organization has started activities of natural resource management, formation of SHGs for self-employment and skill development trainings. Our team has joined with capacity building activity of “Gram Sanjivani Samiti” in Khambha, Dhari and Amreli blocks of Amreli districts also we could encourage farmers of Jafrabad block for formation of their own company.

## Programs

### General Health & Awareness

Trust has provided training to Gram Sanjivani Samitis which were formed under one of the activities of National Rural Health Mission in the year 2007. Training has been organised for member of committee about awareness and capacity building for their services and structure of health function. We have been involved for this work in Amreli, Dhari & Khambha blocks of Amreli district and trained 1206 members of those committees.

Program team of the trust provided guidance to farmers and labour to use personal protective equipment. Personal protective equipment (PPE) is used to reduce or prevent a worker's exposure to health and safety hazards on the farm. while spraying pesticides in field, because after enter in field of agriculture we have found that this is also hazardous activities which neglect by farmer or labour during season. So team spread awareness about this in field area by demonstrating it.





### **Education & Child Right**

As per our experience while working with SMC, we have found that SMC has very crucial role in actualizing the goals of RTE. Through its positive action and a constructive dialogue with other stakeholders the SMC can work towards reinstating a well-functioning school system. We are trying to strengthening School Management Committee. Through meetings our team members in field tried to inspire the members who have engage in SMC including members, elected representatives and community leaders so that they can participated actively. Through SMC we are trying to ensure education of each child in age group upto 14. We are also spreading information about child rights in school and with children and community by decent work of our one program.

### **Education for Slum student**

Till the beginning we focus on the issues for the children living in slum area. They are unfortunately not able to get education because of most of families resides near railway track area and in garbage picking and begging occupation, also children join their family member in this work. We visited to those areas and motivate the children and families for good hygiene, proper balanced diet, RTE act and free education for children. We also

inspired them for better livelihood options and to keep free children from child labour.

We have also conducted survey of slum area near by S. T. Division, Lathi road, Amreli and registered 32 children in previous year and started a class 19 children but because of continuous migration other children have been migrated in other areas. We got success to promote this challenging work.

### **Generate Self – Employment and Micro Finance**

Amreli district is a drought prone area in the Saurashtra region of Gujarat. Majority of the community here are farmers, however they are unable to do farming due to lack of water as a result of scanty rainfall. Since the farming here is not able to sustain the livelihood, the people belonging to poor class, especially the agricultural labour class, families below poverty line and marginal farmers are bound to migrate to distant areas in order to sustain their livelihood.

### **Farmer Producer Organisation**

Jafarabad Agriculture Producer Company Ltd. is registered under company act on 12th January, 2016 with support of NABARD. This company is now in business of agriculture inputs.

Jafrabad Agriculture Producer Company has started procurement of Groundnuts on Minimum Support



Price (MSP) with support of GUJPRO and NAFED during Kharif. In this year total 49233 bags (each bags have 35 kg) (17231.55 quintal) of Groundnut procured for a total value of Rs. 7.75 Crores and more than 750 farmers have got benefits of MSP.

In purchase & selling of agri inputs total 2000 packets of Trichoderma Viridi were prepared from raw materials and distributed to farmers in minimum price of Rs.60/kg to protect their crops naturally. Trichoderma is a one type of useful fungi which destroy the non useful and harmful white fungi.

### **Exposure Visit / Meeting & Training**

Exposure visit of project area farmers was organised at VRTI at Kutch. Here farmers try to understand the scientific purpose and use of new technology in agriculture and also get useful information about market. Various meetings and trainings were organised for farmers, CEO and BOD at inside & outside of office.



### **Skill Development Training Centre**

We are trying to provide training to women, so they can earn from their skill. Organisation time to time organise Capacity Building Training for women of villages where we are working. First we find out the need of women and as per their need we are organising training. We are trying that due to such training and own capacity they can become self reliant. We have did follow up completed training program and guided them for Bank loan, Business plan and needful support for marketing. Most of trainees are members of Self Help Groups. Organisation has also provided vocational and motivational guidance, advice and information.



In last three years we have provided training to women & youth for skill development like Handicraft, Mahendi & Eyebrow, Assistant Beauty Therapist course and Test and Repair Technician. Total 105 beneficiaries got benefit of these trainings and join hand in new skill with support of NABARD & NSHM for NULM scheme.



## Natural Resources Management Better Cotton Initiative

We realized that since many years, the condition of farmers is poor because of many reasons like using old traditional farming technology, unavailability of necessary water resources, dependency on rain, lack of knowledge in farmers regarding new scientific farming technology and harmful use of pesticides and fertilizers, high cost of seeds and pesticides, improper link between farmers and market etc.. The project enabled the farmers to improve their livelihood by converting their small agricultural areas to be more remunerative and sustainable. It also had a positive impact on the environment, as it has increased the green cover in the area and protected the beneficiary insects from harmful harvesting techniques. Thus to improve better farming practices with the help of BCI and Cotton Connect, we did baseline survey in Babra, Amreli and Khambha block of Amreli district and identify 37 villages and select 7500 farmers.

## Project is started with the objectives of...

- To develop better understanding of challenges and strengths of BCI Cotton farm groups
- To identify areas of strength & improvements with special focus on Sustainable Cotton Cultivation Practices
- To identify areas where Cotton Connect can support BCI Cotton Farmers to reduce agri input costs, improve yield and profitability for the farmers
- To understand the impact of supportive training on BCSS (Better Cotton Standard System), Better cotton yield, quality and M&E system.

In this project we work with cotton growing farmers to increase their livelihood by making them knowledge enriched also and addressing solutions to the problems faced during routine cotton cultivation practices.

**Success Story**

Name : Sureshbhai Manjibhai Talaviya

I am Talaviya Sureshbhai Manjibhai. I live in Pir Khijadiya village of Amreli district. I belong to farmer family. As we see Amreli is leading district in cotton production. Due to lack of irrigation system in the farm, most farmers are dependent on rain water. Generally we are growing cotton, groundnut, sesame and black gram, green gram and maize as intercrop.

I am owner of 8 acres of fertile black soil. Before I have growing cotton as per traditional knowledge and the distance between two rows is 60 inches. But after joining BCI program and getting guidance from FF, this year I have planted cotton with 30\*10 in 4 acres of area. Thus, the number of plant increases and also ratio of production will increase.

I have shown black gram, green gram and maize as intercrop in remaining 4 acres of land. I know the benefit of this scientific farming because there are two advantage of intercrop sowing, one is moisture of soil remain and second is if cotton crop ruined then intercrop will give benefit to me.

Before I am giving irrigation to each row but after guidance of the BCI Project, now it is given one by one. Due to this we have found benefit in diseases and decrease the cost of irrigation and saving the water.

Before Joining in this project I don't have system of writing the cost for each item, so I cannot calculate the expense and income. But now I have filled the FFB and have accurate data of expense. I have got guidance that how to get good production in less expenses and importance to save precious resources like water and how to balance environment through BCI program.

We could make farmers success to realise that coming together as a procedure organization will enhance their bargaining power and thereby benefit them mutually through better incomes from agriculture and allied activities.

### ***K.J.D- Krushi JalDoot***

We all are aware that insufficiency of usable water is the big issue now a days and this is the right time to think about the proper use and protection of the available source of water. The effective measures to conserve water when it was available and the general public especially farmers had been aware through campaign to make a more conscious effort to manage water prudently.

To create awareness among the people, especially in rural areas to undertake efforts on water conservation and as per the guideline from NABARD we have organised JalDoot training at the centre of Hariraj Charitable Trust-Amreli on 12<sup>th</sup> May-2017 regarding the importance of water. 20 JalDoot were participated in this training and accept the challenge to spread awareness in 241 villages of Amreli, Dhari, Khambha, Babara and Jafarabad block during the period of 12/05/2017 to 18/06/2017. We run this campaign through various forms. We organised meetings with farmers, women and local public and guide them to use new scientific technology to decrease the misuse of water. We also discussed about dug well recharge, desalting of old tank, necessary of check dams, cleaning/de-weeding of village ponds, construction of rain water harvesting units, adoption of MIS and sprinkler, tree plantation etc to store and reuse of water. Many farmers realised and promised for proper use of water.

Hariraj Charitable Trust was founded in 1993 by Nayanbhai Gandhi. Hariraj Charitable Trust is a registered charitable trust under the

Executive committee handles the operational work of the Trust. Minutes of both Executive Committee & Executive Committee are documented and circulated. The Executive Committee of Hariraj Charitable Trust met 3 times in financial year 2017-18 on 30th June, 2017, 1st October, 2017, & 9th January, 2018. Trust board met 2 times in financial year 2017-18 on 24th July, 2017 & 9th January, 2018.

## Staff Meeting

Every month staff meeting has been arranged with a view to interchange of thoughts and experiences and to increase intimacy among team members. In this meeting, project wise work review, difficulties, instruction, target, future planning

etc. has been discussed. Responsibilities of internal evaluation have given to team members. When a new member joins in a team at that time the organization informed him about vision and mission of the organization and short instruction about why organization is being started? The collaboration between organization and Government, what is the voluntary activity, registration of the organization, body, rules, trustees, structure, income expenditure etc. If any members who participated in any training/meeting during the month then he did brief presentation on it in meeting and if team member found that it is totally new for them then it will present among them in detail.

## Other Committee Meeting

Organization formed various committees for effective management and administrative work and as per policy meeting was held during the year.
